Sir/ Madam,

Please refer to your proposal for Establishment of new medical college at Raigarh, Chhattisgarh in the name and style of "Late Shri Lakhiram Agrawal Memorial Government Medical College, Raigarh" by Government of Chhattisgarh u/s 10A of the IMC Act, 1956.

In this connection, I am directed to inform you that the scheme submitted by you along with compliance submitted at the time of hearing on 26/06/2013 and Assessment report (14^{th} & 15^{th} May, 2013) has been considered by the Board of Governors at its meeting held on 25^{th} & 26^{th} June, 2013 and it has been decided as under:

"Considered for 50 admissions instead of 100. Approved, subject to undertaking by the Chief Secretary for fulfilling the MSR for 50 seats."

In view of above, the Board of Governors is of the opinion that a Letter of Intent for Establishment of new medical college at Raigarh, Chhattisgarh in the name and style of "Late Shri Lakhiram Agrawal Memorial Government Medical College, Raigarh" by Government of Chhattisgarh with an annual intake of 50 (Fifty) students with prospective effect u/s 10A of the IMC Act, 1956 may be issued.

However, this letter of Intent is subject to fulfillment of the following conditions:

- (i) The applicant should provide all infrastructural facilities in terms of teaching and non-teaching staff, buildings, equipments and hospital facilities as per Medical Council of India norms.
- (ii) No student should be admitted in the above college till the formal permission of the Board of Governors is granted.
- (iii) Submission of Undertaking by the Chief Secretary for fulfilling the MSR for 50 seats.

A formal permission of the Board of Governors for Establishment of New Medical College at Raigarh, Chhattisgarh by Government of Chhattisgarh u/s 10A of the IMC Act, 1956 would be granted on receipt of a compliance letter fulfilling the conditions enumerated above. The acceptance letter should reach the Council office within one week from the date of dispatch of this letter to enable the Board of Governors to issue Letter of Permission for the academic session 2013-14.
